Lodging Facility

Includes: Hotels, Resorts and Campgrounds

The base rate for lodging facilities is found on the above standard business sliding scale; in addition lodging facilities must pay:

Per Bedroom - \$4 Per Campsite - \$0.75

Example: A lodging facility with 10 employees, 20 campsites, 12 hotel rooms and 3 three-bedroom cabins would pay \$371

Base Rate = \$272

Hotel Rooms: 12 x \$4 = \$48

Campsites: 20 x \$0.75 = \$15

Cabins: 3 cabins X 3 bedrooms X \$4 = \$36

Civic Member

Includes: Non-Profit Community Groups, Government Entities, Schools, etc.

These members' dues are based on the number of employees.

0-3 employees - \$113 4 or more employees - \$283

Sole Proprietorship Member - \$226

Includes: Individually owned construction companies, independent insurance companies/agencies.

Qualifying businesses must not employ more than the owner and spouse. Members may work from home, or rent/own off-site retail or office space. These businesses have no employees.

Home Based Member - \$113

Includes: Independent Sales Consultants such as Avon, Pampered Chef, etc.

Businesses are based and operated at consultants' home or vehicle; with limited inventory, distribution and are not required to operate with a license or certification. There are no employees other than the consultant.

Associate Member - \$29

Includes: Chamber Ambassadors that are not a member through a member business.

These members do not represent any business or organization and do not have voting privileges.
