Tuition

Tuition for Leadership Caldwell is \$595.00 and due upon application. Tuition covers all program costs including the retreat, lunches, transportation and graduation. Upon invoicing, payment may be made by check or credit card. Payment is due by September 7th. If an applicant cancels within 10 business days prior to the retreat, one-half of the full tuition will be forfeited. If an applicant cancels after the retreat the entire tuition will be forfeited.
