The most impressive structure on the property is the Pavilion Center. This massive building seats at least 10,000 people. The Pavilion Center is also used for annual conferences.

The Redeemed Christian Church of God campus also includes a water tower and residential cabins. The property also features a large meeting hall for rent.

RCCG is the parent company of Hope For You, a charitable organization that helps families in crisis by supplying immediate needs like food, clothing and other essentials. In the near future, they plan to assist qualified families with financial aide and financial counseling.
