

Rules of Participation:

1. You may choose one of the following three levels of participation. Please note: these funds do not benefit the Chamber, but merely cover the cost of prizes, advertising, police details, and tickets.

a. Pay \$500: Receive up to 8,000 tickets, in rolls of 1,000 or 2,000. Businesses using more than 8,000 tickets (8 rolls) will be charged an additional fee of \$50 for every additional roll of 1,000 tickets (Excluding Diamond & Platinum Members).

b. Pay \$325: Receive 5,000 tickets, in rolls of 1,000 or 2,000. Businesses who would like to purchase any additional rolls will be charged an additional fee of \$50 for every additional roll of 1,000 tickets (Excluding Diamond & Platinum Members).

c. Pay \$100 per roll of 1,000 tickets - you must agree to dispense tickets for all 8 weeks, or whenever you are open, buying more rolls as necessary.

2. Customers are given one ticket for every \$25 spent and received at the time of purchase (not financed amounts), regardless of type of payment (cash, check or credit card) **from Friday, Nov 1-Monday, Dec 23. Red ticket distribution will end at the close of business on Monday, Dec 23.**

3. **Please pick up your tickets on or after Nov 1st at the Chamber office.** Tickets will not be issued without payment. You may distribute tickets to customers starting November 15th.

4. This year, our 8th annual HOME FOR THE HOLIDAYS (featuring double red tickets) falls on both **Sat, Dec 14th and Sat, Dec 21.** Participating businesses must give out 2 tickets for every \$25 spent. Participants **MUST** offer refreshments or entertainment in their shops that day. Our December ad will focus on this special day and highlight member offers. Be sure to stock up on ticket rolls by Fri, Dec. 7th. Check the Chamber website and social media for **additional double red ticket opportunities** that we are planning for the island's small businesses! If you would like to sign your business up for a double red ticket day please contact marina@nantucketchamber.org!

5. Tickets and unused rolls (labeled with your business name) **MUST be returned to the Chamber office NO LATER THAN 10 AM ON DEC 24th.** You may drop off tickets prior to the 24th. To keep the event on schedule, businesses must be responsible for separating tickets. Strings of tickets will not be accepted.

6. If you are collecting red tickets for a non-profit organization, please inform a representative from the organization that they must pick up the donated tickets from you, be present at the drawing, and have their organization's tax ID number available.

You will be given a poster to display in your window identifying you as a participant. Display ads listing participating businesses will appear in two community advertisements: one in November for everyone & one in December for Home for the Holidays participants **ONLY**. Only businesses that have paid for their tickets will be listed in the ads.
