



**FUNTIER DAYS  
ARTS AND CRAFT SHOW  
BANDERA, TEXAS  
MAY 26th & 27<sup>TH</sup>. 2018**

**GROUNDS:** Held in downtown Bandera on the Courthouse lawn.

**ELIGIBILITY:** Open to individual artists and craftsmen presenting their original works. No manufactured, imported or resale items will be allowed **in the Arts and Craft area** – only original works and prints by exhibiting artists. Demonstrating your art or craft, while not required, will be a consideration when booths are being assigned. Bandera Chamber of Commerce reserves the right to reject any display that is not in keeping with the examples submitted to jury. Food booths will be limited and be given exclusive rights to your food items submitted (no duplicates on main food items allowed)

**City Permits Required: Applications on line at [CityofBandera.org](http://CityofBandera.org)**

**SELECTION PROCESS:** A group of Artists and Craftsmen are selected to help us make decisions as to who will be allowed in the show. You may submit photos or web sites or samples of your work. Juried booths receive spaces in the front of the court house in high traffic areas. Commercial items are allowed but those spaces are typically located on the sides of the court house.

**REGISTRATION:** The registration fee is \$90.00 per space for the two-day show. There will be no price limit on your items sold and no commission will be taken. All registration forms must be accompanied by photos, a web site or sample of your work, and a check or money order payable to Bandera Chamber of Commerce. **Your check will not be cashed until you have been accepted into the show. Deadline for application is May 18<sup>th</sup>, 2018.**

**SPACES/ ELECTRICITY:** Open spaces *only* are provided and are 10'x10'. You provide your own canopy. If you plan to use a canopy, tent, or umbrella, please specify and give dimensions. There are a limited number of spaces available. Electricity is available on a strictly limited basis at an additional charge of \$10 per space, only to those **cooking** or **demonstrating** an art or craft. All circuits are Twenty Amps.

**NOTIFICATION OF ACCEPTANCE:** Artists will be notified of their acceptance no later than **May 21, 2018**. **You will receive an information packet no later than May 25, 2018 by e-mail.** *There will be no refunds after May 25, 2018 and no refunds should bad weather occur.*
