NOMINATION REQUIREMENTS

- ✓ When nominating a business, the nominee must be aware and approve of the nomination
- ✓ Non-profit organizations must provide their non-profit organization/registration number
- ✓ Must be a Brampton-based company, and community efforts that directly impact Brampton
- ✓ Must submit hi-resolution version of logo
- ✓ Maximum of 3-5 supporting documents to be submitted
- ✓ Nominees after two consecutive years are ineligible
- ✓ Previous award recipients are ineligible to receive award for the same category as previous year

Nominees will be assessed based on the following eight characteristics:

1. Demonstrate **leadership excellence** through developing a vision for a stronger Brampton business community and **inspiring others** to work toward that vision.
2. Uses traditional and new **communication techniques** to engage the community and customers in an **innovative** way.
3. Provides an example of what can be achieved when **working collaboratively** to attain a goal and demonstrates characteristics such as **team spirit**, combining talents of traditionally separate units, and/or partnerships with other businesses.
4. Exemplifies the **spirit of risk and innovation**, while growing their business and contributing to the **vibrancy and diversity** of Brampton's business community through their achievements.
5. Contributes to the quality of life of the greater Brampton community by demonstrating that **commitment and responsibility** aren't confined to business and their **impact** can be social, cultural or environmental.
6. Helps support youth, newcomers or new entrepreneurs to thrive in our business community by investing time to **mentor, teach, coach** and develop excellence in others.
7. Promoting, **exporting** or **importing** their products or services internationally to bring Brampton to the world, and the world to Brampton.
8. Encourages a **healthy workplace** and understands that a culture of **wellness** is tantamount to supporting employee and business health by focusing on **employee welfare** and investing time/resources, the nominee has seen significant change and success within their business.
