- ✓ The nominee must be a current resident of the city of Brampton or work for a business/organization operating within the city of Brampton and whose leadership in the city is worthy of recognition.
- ✓ Nominees must be under the age of 40 as of December 31, 2019.
- ✓ Previous Top 40 Under 40 recipients are ineligible.
- ✓ Completed application along with supporting documents for consideration.
  - i.e. reference letters, media articles, measurable influence (e.g. do you have a large social media following/presence?) *Please note: supporting documents should be as current and to date as possible.*
- ✓ An impact statement describing the nominee's involvement and impact in the community of Brampton. 150 words maximum. We are in search of outstanding individuals who go above and beyond the call of duty at their workplace, community or industry.  
*Please note: The Brampton Board of Trade reserve the right to edit the statements submitted.*
- ✓ Hi res headshot of nominees to be submitted at the same time of application. 300 dpi at 4" x 4" is preferred.
- ✓ Maximum of 3-5 supporting documents.
