We'll spend the evening sipping wine or brews while sampling zesty barbecue, gourmet pizza, delicious pasta, sweet treats, and so much more. Try what you like or try it all! We're anticipating a turnout of 1500 people for an evening of fun, food, drinks and music! Sip & Savor is an outdoor event held at the beautiful 370 Lakeside Park. Plenty of seating will be available. Setup time is **2:30pm** on Thursday, September 7th. There is no fee for Chamber members to participate if you book your booth *before June 30th*, we are only requesting a \$100 deposit (refundable if area is left cleaner than when it was found, but forfeited in a no-show situation). Registration includes your booth space, 2 eight-foot tables clothed (one is brightly skirted), four vendor passes (if more are needed they can be purchased) a 10x10 tent, and appropriate licensing from the City of St. Peters. Signage and electricity are available as add-ons, or bring your own banner! If you have any specific requirements for your booth please let me know in ADVANCE. An extensive marketing plan has been developed to promote the event and our participating vendors.

Tickets for guests and the public are available in advance for \$30 each and will increase to \$35 the week of the event. This year we have a limited # of One Day Deal tickets for \$25 and group ticket pricing for groups of 10 or more (tickets must be purchased together) for \$25 each. This is an all-inclusive priced admission for all food, beverage, and live entertainment. Please mail the enclosed application and payment to reserve your booth in this year's event. You won't want to miss out! **We will be limiting booths to the first 50!!! Don't wait, it will be a sell-out like in previous years!**
