- Vendors must be completely set up by 11:00 am.
- Absolutely **No** vehicles on grass for set up, push carts allowed.
- **Merchandise NOT permitted: marshmallow guns.**
- Fee per space (10' frontage) – Stafford Chamber Members Only (***Food vendors are required to be Chamber Members**)
 - Food Vendor (full menu) -\$150
 - Food Vendor (snacks only) \$100.00
 - Craft/Business Vendor - \$40.00
 - Non-Profit --\$0
- Fee per space (10' frontage) – Non-Stafford Chamber Members
 - Craft/Business Vendor - \$80.00
 - Non-Profit - \$25
- Fee for a 2nd table for the **SAME** business will be ½ price
- **If electricity needed, prior notification is required plus an additional fee of \$25.00**
- (No generators permitted unless previous approval given)
- Please fill out vendor registration, make checks payable to “*Stafford Chamber of Commerce*” and mail to the address below (post marked by **March 16, 2018** all other registrations received after that date will be reviewed and selected on a case by case basis). If mailed after deadline, a late fee of \$25 applies.
