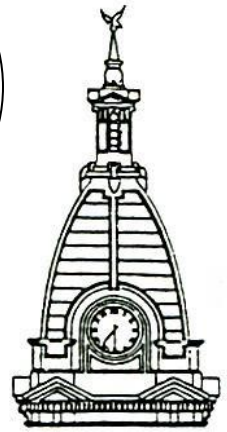

Spring Fling & Down Home Days Courthouse Shows

Saturday, May 6, 2017 & Saturday, September 16, 2017

Mason, Michigan – Hometown U.S.A.

Our 34th annual Spring Fling Courthouse Show on May 6, 2017 and our 44th annual Down Home Days Courthouse Show on September 16, 2017 are both outdoor shows held around the Ingham County Courthouse in downtown Mason and are held rain or shine. Show hours are 9 AM to 4:30 PM. The 130 lawn and 20 street spaces are each 10' x 10' and the fee is \$60.00 per space. Exhibitors may set up any time after 6 AM on the day of the show. This show is non-juried and applications are accepted on a first come, first served basis until all booth spaces are reserved or until 3:00 p.m. on the Thursday before each show, whichever comes first. No electricity is available. No tables or canopies are provided. No carpeting or flooring of any kind is allowed. We also must insist that you set up 18 inches from the sidewalk in most spaces to avoid sprinkler lines. Free parking after setup must be in designated municipal lots. No parking all day in two-hour spaces!

You will receive a postcard confirming your exact booth space soon after March 15th for Spring Fling and soon after July 15th for Down Home Days. Local and state governments have requested that we furnish them with the sales tax license numbers of our exhibitors, if required. The **City of Mason** has requested that we furnish them with the vehicle license numbers of our exhibitors, as parking all day in two-hour spots is prohibited. There is a space on the application form for you to provide those numbers. If you need to get a sales tax number, you may contact the Michigan Department of Treasury at 517-636-4660 or apply online through the www.michigan.gov website. There are also separate availability, fees, applications and procedures for a small and limited number of food vendors. Please contact the Chamber for information and food vendor applications.

If you were an exhibitor at the Spring Fling Courthouse Show in 2016, you may have your same booth space in 2017 if we receive your application and payment by March 15, 2017. If you were an exhibitor at the Down Home Days Courthouse Show in 2016, you may have your same booth space in 2017 if we receive your application and payment by July 15, 2017. This year, we will again be assigning new vendors to three sections in each show: "Artisan's Row" for arts & crafts, "Community Corner" for local groups, and "East Market" for flea market and manufactured items. Only one vendor for certain manufactured items is allowed (i.e. Tupperware, Mary Kay, etc.). Requests for Spring Fling Courthouse Show refunds will be honored, less a \$10 handling fee until April 1, 2017. Requests for Down Home Days Courthouse Show refunds will be honored, less a \$10 handling fee until August 15, 2017.
