



Dear Artisan,

The Bar Harbor Chamber of Commerce will once again host its' annual Art in the Park show this June 15 & 16 on the Village Green in downtown Bar Harbor. As the longest running art show in Bar Harbor we are honored to celebrate 69 years of supporting and showcasing fine art painters, photographers and print-makers.

Art in the Park's mission is to allow artists the opportunity to present and sell their original works in the two-dimensional art mediums of painting, print making and photography. The event is open to the public.

Event Details

Dates: Saturday & Sunday, June 15 & 16, 2019

Times: Show open 10am to 5pm (both days)

Event Guidelines and Terms of Participation

- Artists must be present with their work for the entire two days of the Art Show. Representatives may not attend in place of the artist.
- Artist are assigned an approximate 12' x 12' booth space (to accommodate a 10' x 10' tent) on the lawn areas along the walkways within the Village Green.
- Only one artist is permitted to display per booth space.
- Setup can begin no earlier than 7am on Saturday morning.
- Artists must not break down until the end of show.
- Clean up and removal must be completed by 6 pm on Sunday.
- Due to underground irrigation, the use of in ground stakes and anchors is prohibited. It is recommended that artists use weights to anchor their tent in the event of windy conditions.
- Overnight security will be provided from 6pm on Saturday to 8am on Sunday.
- Artist are asked to only display original, two-dimensional art in the mediums of painting, print making and photography. Reproductions and/or works displayed on craft items such as t-shirts, jewelry, mailboxes, etc. may have to be removed from display.
- Exhibitors will be responsible for collecting Maine State Sales Tax.
- Vehicles must be parked in designated areas by order of the Town of Bar Harbor. You may not load or unload in the hashed spaces surrounding the Village Green reserved for the Island Explorer buses.
- The Chamber, its sponsors and contracted security agency can not be held responsible for any loss or damage to booths or contents.



In addition to supplementing the costs associated with planning and executing the show (including park use and overnight security), booth fees will fund the following marketing efforts in 2019.

- Event listing on Bar Harbor Chamber of Commerce’s online calendar and featured on VisitBarHarbor.com, which delivers millions of page views annually.
- Advertisement in the Mount Desert Islander and other regional outlets.
- Press Releases sent to local and statewide media outlets.
