### BUSINESS OF THE YEAR

(Generally more than 100 Employees):

- Involvement in the Chamber.
- Unique or innovative approaches towards growth, customer service, community involvement, etc.
- Demonstrates staying power, adaptability and response to adversity.
- Must be established for a minimum of four years.

### BEST PLACE TO WORK:

- Involvement in Chamber.
- Employee satisfaction, benefits, perks, work/life balance, etc.
- Unique company culture and traditions.
- Must be established for a minimum of four years and have more than 10 employees.

### VOLUNTEER OF THE YEAR:

- Has contributed great volunteer service for the Chamber or in the ChamberWest area.
- Has demonstrated a passion to work for positive progress in the ChamberWest area.
