## South Baldwin Chamber Ribbon Cutting Policy

### To be eligible, Members must meet one of the following:

- Be a new business that has been open 9 months or less
- New location for an existing member (ribbon cutting should be within 9 months of moving)
- Major expansion or new division/addition with sufficient job creation
- Additional locations (must join as a member prior to scheduling)
- New home-based businesses (ribbon cutting will be held at Chamber Office)

### Not eligible:

- Change of ownership under the same business name
- Professional Sales Associate members
- Businesses that have been in existence longer than 9 months
- Businesses who have relocated longer than 9 months

### Ribbon Cuttings are promoted as follows:

- Through email communications to the Chamber's Board of Directors, Diplomats, Elected Officials and Staff
- Under Member News on the Chamber website [southbaldwinchamber.com](http://southbaldwinchamber.com)
- Posted on the Chamber's Facebook page, after the event
- A press release, written from info provided by the member, will be submitted to local media outlets with no guarantee of it being published
