4. Each exhibitor is responsible to clean up area used by exhibitor.
5. No food or drinks are to be sold by exhibitors.
6. No tear down prior to 8pm. Vending is until 9 p.m. Streets clear by 11 p.m.
7. No receipt will be sent for checks; your deposited check will be your evidence of acceptance in show.
8. No cars or trucks will be allowed to park on show property.
