(Payment must accompany the signed registration form for deposit to be held until selection is made)

REGULATIONS

1. Fire extinguisher must be provided.
2. If you are selling non-prepackaged food, you must carry a public and product liability insurance in the amount of \$1,000,000 and name the Gig Harbor Chamber of Commerce as additional insured. **A copy of insurance MUST accompany your application.**
3. You must apply for your own Pierce County Health Department Permit. **The deadline for your Food Vendor Application & Health Department Permit is April 18, 2018.** The cost of the permits and compliance with Pierce County rules and regulations is your responsibility.
