Policy and Regulations



Welcome to the 29th Annual NATIONAL BABY FOOD FESTIVAL GRAND PARADE. We are happy to have you as a participant in the parade and would like to thank you for helping make our celebration a more colorful event. The Nestlé Nutrition/Gerber Products Grand Parade will be held on **Saturday, July 20, 2019** during the National Baby Food Festival. Entries must be for the specific purpose of enhancing or promoting the Grand Parade and the Festival and will comply with the guidelines established.

The 2019 NBFF theme: **“The Roaring 20s”**

All applications are subject to the approval of the National Baby Food Festival Grand Parade Committee. Deviation from the following terms and placement in the line of the Grand Parade will be made at the sole discretion of the Parade Committee.

In a continued effort to “Go Green” we are asking that you provide an email address for the committee to send out your confirmation. Confirmations will be sent no later than July 5, 2019. If you have not received your confirmation in a timely manner, please check your “spam email” file. We ask for your cooperation by observing the following:

1. Entry applications must be in the Fremont Chamber Office no later than June 28th, 2019. A response email or phone call will be received within 2 weeks or as soon as possible, considering the date application is received.
2. Please **keep** this "information sheet" from the enclosed packet. **ONLY The Parade Entry Form and Application Must Be Returned.** Describe in three or four sentences your entry for the announcers to read on parade day. Tell us about your organization and people involved in your entry. Describe the float, materials, use of theme, etc.
3. **“Parade Officials”** (wearing Festival shirts) will be at the parade site to further instruct you to your designated line-up area. Look for the registration table, located near the Northwest corner of the school. A map will be provided, via email, with detailed instructions once your application has been accepted.
4. **Parade Wranglers** will be stationed throughout the parade route to ensure the safety of all spectators and parade participants. The wranglers are considered “Parade Officials” to provide assistance and report concerns back to the festival committee. This ensures a safe successful event for all to enjoy.
5. **Entries of a social issue**, ones that generate emotional and ethical opinions WILL NOT BE ALLOWED.
6. **All float entries must register by 9:00 am and be in place no later than 9:30 am.** Judging will begin promptly at 9:45 am. Winners will be announced and awards will be given prior to the start of the parade.
7. **The parade will step-off at 10:30 a.m. sharp.** Assistance will be given during parade day at the registration table. **All participants must check in at the registration table.**
8. **Leave 25 feet between you and the entry in front of you. Please make every effort to keep the parade moving.** If you are having a problem, please pull off to the side and allow other entries to proceed. Parade wranglers will be stationed along the route to facilitate a smooth flowing gap free parade.
9. **Equestrian/Horse units must provide their own clean-up crew.**

10. Passing out candy, balloons, etc., by a walker, is welcomed if approved by the Parade Committee in advance. In the interest of safety, parade participants are **not allowed to toss or hand out** any materials anywhere on the parade route **from the units**. A violation of this rule will lead to immediate disqualification.
11. All vehicles must have valid vehicle insurance, be clean and in good running condition.
12. For the safety of all spectators and participants, absolutely **NO BURN OUTS** will be permitted by any vehicles in the parade.
 - * First violation - participants will receive a warning.
 - * Second violation - will result in exclusion from future parades.
13. Floats must be equipped with Class "A" fire extinguisher. No riders will be permitted in the bed of the pulling vehicle.
14. **No alcoholic beverages may be consumed or displayed during the parade.**
15. **Drivers of motorized vehicles must be at least 18 years of age.**
