

# 68th Annual Flambeau Rama

## Arts & Crafts Fair

**SATURDAY, AUGUST 1ST, 2020 9:00 AM - 3:00 PM**

The Arts & Crafts Fair is a popular tradition at our summer festival, Flambeau Rama. This year it will once again be in DOWNTOWN PARK FALLS. We welcome back our returning crafters and extend an invitation to new vendors. You will need to return your completed registration form along with full (non-refundable) payment by **Friday, July 10<sup>th</sup>, 2020**, in order to reserve a spot in the Fair. You will receive directions & a map with your confirmation letter. The booth fee is \$50.00 for one (10' x 10') booth space, and \$75.00 for two spaces. Each additional booth will cost \$30.00 per booth space

The Arts & Crafts Fair will be outside RAIN OR SHINE and will offer accessibility to all of our attractions and great visibility for the Arts & Crafts Fair.

Booths will be placed to provide the most visibility for vendors while reducing congestion. We will again be separating our Arts & Crafts Fair into two different areas. Please remember to mark on the application whether you will be selling handmade items or non-handmade items. We are not a juried show. However, it has been brought to our attention that vendors from both categories prefer to have separate vending areas.

Set-up will be Saturday from 6 am. - 9 am. Prior to the event. There are **NO STAKES** of any type allowed. All tents must use weights to secure them. An event supervisor will be available during these time periods and throughout the fair. We would like all large trailers and motor homes to set-up early to avoid congestion. When you arrive, booth assignments will be posted at the registration table on the corner of 2nd Ave and Division St. so you can proceed to your assigned booth area and begin setting up. Please do not begin tearing down your booth before **3 pm** on Saturday. If this happens people will think the show is closing and some of your best sales can be at this time!

Vehicles will be allowed into the fair site for unloading. After unloading, vehicles will need to be moved to the designated parking area to prevent congestion with other vendors setting up.

Access to food and beverages will be at local merchants and the Fair ground. The Chamber has many attractions and events scheduled throughout the three day festival, including FREE musical entertainment under the big tent, a carnival, and a huge parade on Sunday at noon.
