NO \$15K CAP FOR EIDL LOAN

As of today 4/13/20, according to SBA, there is no \$15K cap for the EIDL loan amount.

There was much press last week about the money running out and a \$15K cap in place, but we just heard from SBA that as of today 4/13/20, there is still plenty of money to lend out and there is no \$15K cap.

We will send out any updates as we get them.

There have been no changes to the application for sole proprietors and 1099 people. Everyone is now allowed to apply including agricultural businesses.
