PLEASE READ

Our “Berry Fair” Street Market will be dedicated to juried arts and craft booths, cottage food industry & selected boutique products. Applications will be reviewed by a jury that will take into account past participation, product type and quality. Items may not be mass produced. We aim to have a large variety of offerings. A few spaces will be reserved for our major festival sponsors which may be commercial vendors.

The festival will have 8-10 booth spaces available in the kids’ zone. Each vendor in the kids’ zone needs to provide a **FREE** activity for kids. (coloring, mask making, play dough, bean bag toss etc...) The kids’ zone is held in the parking lot right in front of the street market. Those spaces may be run by commercial businesses to promote their business for example, banks, insurance and even retail, you just need to offer an activity. By providing a free activity for kids, you will not only enhance the community spirit and involvement of the Northwest Raspberry Festival, but attract more visitors to your booth. There is no easier way to get adults to your booth than by getting the attention on of the kids with them. The chamber has a list of ideas if you need help deciding on an activity.

In order to participate in the kids zone you must be a current Lynden Chamber of Commerce member. Participates will be based on past participation and booth activity.





Berry Fair Artisan Market Vendor Application

Vendor Fees

Street Market & Kids Zone Vendor Fee is \$90 per space and is due with your application. Vendor fees can be paid with cash, check, Visa or Master Card. No more than 2 spaces per vendor.

Food Court vendors will need a different application

Vendor acceptance & locations are based on: Years of attendance as a vendor, Chamber membership, Space requirements & Complete application

Please include a photo of your products & if possible your booth

Logistics

- Booth space is allocated in increments of 10 x 10 spaces. The market is on Front Street between 6th & 7th St. You must stay inside the footprint of your assigned space. No displays may protrude out into the walkways.
- We will provide the spaces, you provide your own canopy, table, chairs, etc.... As it can get windy, **We require that you weight your canopy.**
- We reserve the right to refuse entry to any vendor. We attempt to limit the number of vendors selling the same type of items, but do NOT guarantee product exclusivity.
- Any special booth requirements need to be confirmed at time of application and noted on the application.

- Vendors agree to follow the direction of Festival staff regarding load-in/out rules during the Festival, for the safety of all attending.
- All vendors must adhere to on-site decisions of the Festival Staff.**
- It is expected that all vendors will adhere to all local, state and federal guidelines regarding permits, signage, types of items sold, collection of sales tax, etc. City of Lynden sales tax location code is #3705.

Entry Deadlines & Hours of Operation

Deadline for vendor entry is **April 17th** If you are not chosen for the market for any reason, we will return your vendor fee. Any special needs must be discussed in advance. Vendors selected for the market will be contacted by e-mail. Set up information & instructions will be sent at the end of June.
