



**TOUR DE JEFFERSON**

**AGREEMENT and WAIVER & RELEASE OF LIABILITY– ALL APPLICANTS MUST READ AND SIGN**

I, the undersigned, understand and agree that bicycling is a potentially hazardous activity and that I attend the Tour de Jefferson out of my own free will and personal desire. In choosing to attend this Tour and any related events, I acknowledge that the routes traveled will contain active traffic and I fully accept and assume all risks, whether before, during or after the Tour and its related events. All physical and mental risks are known and appreciated by me. I hereby expressly waive any and all specific notice of the existence of any risk associated with the Tour de Jefferson. I agree to assume and pay my medical and emergency expenses in the event of injury, illness, or other incapacity incurred directly or indirectly in connection with the Tour de Jefferson, regardless of whether I authorized such expenses. I hereby acknowledge that this Bicycling Tour requires physical conditioning and I represent that I am in sound medical and physical condition and am fully capable of participating in the Tour without risk to others or myself. I understand and agree that a situation may arise during the Tour, which may be beyond the control of the sponsors, promoters or organizers of the Tour de Jefferson, including but not limited to the Jefferson Chamber of Commerce. I agree that I am solely responsible for the condition and adequacy of my bicycle, safety gear and any riding equipment. I agree that I will ride safely within the limits of the law, in accordance with my own abilities, my equipment and the riding conditions and in a manner so as not to endanger myself and others. Knowing these facts and in consideration of my entry acceptance, admission to and/or participation in the Tour de Jefferson and its related events, I for myself and my heirs, assigns or anyone acting on my behalf hereby release, waive, discharge, covenant not to sue and agree to hold harmless the Jefferson Chamber of Commerce and its volunteers, sponsors, promoters, organizers, vendors and insurers from any and all claims, demands and actions of any and every kind I have, may have or may hereafter accrue against the Jefferson Chamber of Commerce and its volunteers, sponsors, promoters, organizers, vendors and insurers, directly or indirectly arising out of or relating in any respect to my attending or participating in the Tour de Jefferson and its related events. My waiver and release of all claims, demands, actions and liability shall include without limitations, any injury, damage or loss to my person or property which may be (a) caused by any act, or failure to act, by the Jefferson Chamber of Commerce and any of its volunteers, sponsors, promoters and organizers or (b) sustained by me before, during or after the Tour de Jefferson and its related events. I agree to abide by all applicable laws, rules and regulations. I understand that the Tour de Jefferson may use my name, photograph, and/or likeness in its current and future promotional or advertising materials, including social media. I consent to such uses and waive any rights of privacy, publicity or for financial or other payments in connection with such use I may have in connection with those uses. **I further agree to defend, indemnify and hold the Jefferson Chamber of Commerce and any of its volunteers, sponsors, promoters, organizers, vendors and insurers who are released above harmless from any and all losses, damages, claims and expenses, including attorney’s fees, arising from or relating in any respect to my participation in the Tour de Jefferson or its related events or for my breach of this Agreement.** If I am a minor, my parent or guardian also is signing on my behalf and we both agree to be bound by the terms of this Agreement, Waiver and Release. I have read this Agreement, Waiver and Release. I understand that police and Support and Gear Vehicles will end at 11:00 a.m. and if I choose to ride beyond this time those support services will no longer be available for my benefit.

PARTICIPANT AGREEMENT - PLEASE READ THE FOLLOWING RULES CAREFULLY AND SIGN**

1. The Tour de Jefferson social ride will start at 7:30 AM CST on Sunday, October 20, 2019. All participants must arrive to the rider lineup/check-in location (*Parc des Familles – SOUTH Entrance - 6101 Leo Kerner, Lafitte Parkway, Marrero, LA 70072*) by 7:15 AM CST in order to participate. **INITIAL:** \_\_\_\_\_
2. Police coverage on the route will start at 7:30 AM CST and end at 11 AM CST. ALL riders must be off the road by 11 AM CST at the latest. **INITIAL:** \_\_\_\_\_
3. Athletes must select a route that is best for their skill level and that they can complete in under 3.5 hours. (*Route Options: 15 Mi., 31 Mi., 50 Mi., 62 Mi. (100k)*). **INITIAL:** \_\_\_\_\_
