EMPLOYER OF THE YEAR

Must have a minimum of 20 employees. Your self-nomination application must provide evidence of outstanding achievement as an employer in some or all of the following: Employee Relations and Training, Workplace Culture & Values, Community Involvement, Environmental Awareness and/or Innovative Encouragement for Employees.

SMALL BUSINESS OF THE YEAR

Must have BETWEEN 2 and 19 employees. Your self-nomination application must provide evidence of outstanding achievement as an employer in some or all of the following: Research & Development, Company Growth, Workplace Culture, & Values, Products & Services, Market Development, Sales & Marketing, Community Service and Involvement.

NEW BUSINESS OF THE YEAR

Your self-nomination application must provide evidence of outstanding achievement as a new business in some or all of the following: Research & Development, Company Growth, Products & Services, Market Development, Sales & Marketing, and/or Community Service.

ENTREPRENEUR OF THE YEAR

Your self-nomination application must provide evidence of an **INDIVIDUAL** who demonstrates innovations in some or all of the following: Research & Development, Company Growth, Products & Services, Creative Business Initiatives, Sales & Marketing, and/or Community Service.

NON-PROFIT OF THE YEAR

Your self-nomination application must provide evidence of providing exceptional community service and leadership in one of the following areas: Broadened Education of their Service, Innovative Services, Community Involvement, Promotes Volunteerism, Positive Contribution to Society, Social & Community Advancements. Organizations **MUST** be registered with the Colorado Secretary of State as a 501c3.

MANUFACTURER OF THE YEAR

Your self-nomination application must provide evidence of outstanding achievement in some or all of the following: Research and Development, Company Growth, Product & Services, Market Development, Sales & Marketing, and/or Company Service.

YOUNG PROFESSIONAL OF THE YEAR

Your self-nomination application must provide evidence of excellence, creativity and initiative in their business or profession in some or all of the following: Company Growth, Sales & Marketing, Customer Service, Community Service and of being a personal and professional role model for other young professionals. Nominee must be **UNDER 40 years of age** with one (1) or more years of professional experience in their current career. An employee may be nominated by a peer or self-nominate.

PROFESSIONAL SERVICES BUSINESS OF THE YEAR

Your self-nomination application must provide evidence of a business that exemplifies professionalism and integrity. This category includes, but is not limited to, law, medical, dental, accounting, financial, insurance, real estate and other professional service providers. Recognized for outstanding achievements in some or all of the following: Company Growth, Customer Service, Market Development, Sales & Marketing, and/or Community Service.
