### CANCELLATIONS

50% of the rate will be invoiced if The Chamber is not notified within five working days of signing this insertion order contract. Advertiser will be billed for unused ad space if no acceptable copy is provided in sufficient time to meet normal production schedules and stated artwork deadline.

### PAYMENT TERMS

**50% cash payment is required upon receipt of ad space reservation and balance due within 30 days.**

If payment is not received, the Chamber has the right to remove the ad from publication and charge for composition expenses. All balances not paid within 30 days are subject to delinquency charge of 1 1/2 % per month (18% annual). Re-invoicing will be charged at \$5.00 per additional invoice sent. Balances not paid within 45 days will be billed at gross to client.
