## Tuition Schedule

Your tuition investment of \$895.00 covers all program costs, banquet meals, and the team-building weekend retreat. Many employers and sponsoring organizations may wish to pay the tuition for their selected employees or members.

**Payment Terms: This form is detached from your application and used by the Chamber of Commerce for your invoices. A \$150 refundable deposit is required when your application is submitted.** The deposit will be refunded if you are not selected for the program. If selected for the program, your \$150 deposit will be applied to your \$895 tuition and the remaining \$745 is due in full by August 1, 2019. If your \$745 payment is not received by August 1, 2019, a payment plan will be automatically arranged for you. You will be invoiced for three payments of \$275 each. These three payments, along with your \$150 deposit, will total a tuition payment of \$975.

1. \$275 will be due by August 15, 2019
2. \$275 will be due by September 19, 2019
3. \$275 will be due by October 17, 2019
