I would suggest you use the sound blanket as that formula gets inaccurate if you use decimal points. For example, if I put in 72 decibels and measure at 1ft (instead of 0.1) and then 8.5 (to account for that extra foot) it comes out to 53.4 decibels.

With the sound blanket, it looks like you can go from 53.4 to 45, as the minimum there is a 5 decibel reduction.
