**Terms and Conditions**

**Responsibilities of the HPBC Member:**

- 1. The HPBC member (“Member”) agrees to participate in meetings, the annual Green Home Tour (if applicable), and other green building functions as often as possible.
- 2. Builder members of HPBC agree to make every effort to participate in a green certification program. The HBADOC preferred green certification program is the National Green Building Standard (NGBS).

**Responsibilities of the High Performance Building Council of the Triangle program:**

- 1. The HPBC program (“Program”) agrees to offer educational opportunities, at the program’s discretion, that will provide information on green building practices and marketing strategies.
- 2. The Program will conduct a general advertising and promotional campaign, as funds allow, to increase public awareness of the program members and the benefits of green building.
- 3. The Program will provide marketing materials, as appropriate, for distribution to members.

**Other Stipulations:**

The HPBC program is constantly evolving, incorporating new products and methods as they are developed. The program operates according to its own rules of procedure and in accordance with the bylaws of the HBA. Changes in rules, regulations, responsibilities, and documents may be adopted from time to time. The program member agrees to abide by these as well.

This application is a voluntary agreement between the undersigned and the HBADOC, which operates the HPBC program for members of both the HBADOC and HBARWC. Membership acceptance to the program is contingent upon the review and approval of each membership application.

Neither the HBADOC, HBARWC, nor the HPBC program makes any representation regarding the Builder Member or any homes built by the Builder Member. All representations are made by the Builder Member and, when appropriate, the independent home rater or verifier. The HBADOC, HBARWC and HPBC program do not inspect homes or review performance information, and they are not responsible for the accuracy of any information provided by the builder Member or anyone else concerning the homes. The HBADOC, HBARWC, and HPBC program make no express or implied warranty concerning any home including the energy efficiency of the home and are not liable for the usefulness of any product or process used in any home.

The Builder Member agrees that the HPBC program’s name, logo, program documents and other materials belong to the HPBC program and cannot be used without the program’s permission. Any use of the materials must comply with the program’s rules and regulations and must be beneficial to the HBADOC, HBARWC and the HPBC program.

The Builder Member agrees to indemnify, defend, and hold harmless the HPBC program as well as the HBADOC and HBARWC and their subsidiaries members, councils, officers, employees, volunteers and agents from any claims, damages, lawsuits, liabilities, demands, causes of action, contribution toward damages, allegations, attorneys’ fees and costs related in any manner to any actions or omissions of the Builder member or to any homes sold or constructed in whole or in part by the builder Member.
