GENERAL: The application must be filled out completely & submitted with the required fees or it will be rejected and returned. Plumbing work shall not be started until the approved plumbing permit is received by the contractor/homeowner. Work started prior to receiving an approved permit will be required to pay a TRIPLE fee. The Conditional Plan Approval must be submitted with application for projects that require DSPS plan review. Water service and sewer repair, and water heater replacements will be considered emergency work. Permit is to be submitted within 24 hours of the start of the job.
The minimum permit fee is not refundable.

Ordinance repealing and recreating certain sections of Chapter 15 of the Municipal Code, commonly known as the Plumbing Code – fees for permits and inspections.

The Common Council of the City of Brookfield does ordain as follows:

PART I. Section 15.12.060 of the Municipal Code, Chapter 15, relating to the plumbing fee schedule is hereby repealed and recreated to read as follows:

15.12.060 Plumbing Fees.

a. The following fees shall be paid to the plumbing supervisor before the plumbing permit is issued:

1. (a) Each sewer connection to a main sewer or lateral at the curb.....\$54 ~~\$55~~
 (b) Over 100 feet of sanitary building sewer, building drain
 or storm sewer, per foot\$43 ~~\$44~~
2. Each water service connection to municipal system.....\$54 ~~\$55~~
3. Installation of each plumbing fixture or water connected appliance including toilet, bath, urinal, floor drain, sink, laundry tray, basin, bubble, or for each plumbing fixture opening including conductor bends.....\$13.00 ~~\$13.25~~
4. Inside sewer (building drain)\$54 ~~\$55~~
5. Minimum fee for any permit, where no other applicable\$54 ~~\$55~~
6. Minimum for water heater and water softener, water treatment..... \$54 ~~\$55~~
7. Each inspection after the second that is necessary to enforce ordered corrections\$54 ~~\$55~~
8. Each sump pump discharge connection to storm sewer\$54 ~~\$55~~
9. Five Year Well Operation Permit\$54 ~~\$55~~
10. Backflow Prevention Inspection Fees for Non Residential Properties

- b. Penalty for Failure to Obtain Permit. If plumbing work is begun before the permit has been obtained, triple the above fees shall be charged, and the violator shall be subject to the penalties in Chapter 1.12. (Ord. 1672, Ord. 1541 § 1, 1996: prior code § 16.16)


PART II. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.
