1	Fully Fund North Carolina Biotechnology Center: \$13.6M R	Reduces funding by \$680,117 to \$12,920,321. Special provision requires Center to raise one dollar in non-state funds for every four dollars in state appropriations; limits Center allocation for administration and similar functional groups to 10% of appropriation. Allows transfers of up to 10%, except for administrative flexibility, between Center functional groups. Requires that no less than 75% of all state funds awarded by Center be in form of loans. Center officials say these restrictions are very detrimental to Center's operations and seriously limit its ability to strategically address new biotechnology	Maintains current funding at \$13.6 million. Removes Senate matching funds requirement, requirement that 75% of awards be in the form of loans. Changes limit on Center allocation and similar functions to 13.7% (\$1,863,246).
