## Legislative Session Continues



The North Carolina State House has overridden Governor Roy Cooper's veto of the General Assembly's 2019-20 appropriations legislation. The vote was taken on the morning of September 11 during what Democratic legislators had expected to be a no-vote procedural session. Democrats have decried the "surprise" vote as a deliberate deception. Republicans say that the session was never officially designated as a no-vote period. The veto override motion now goes to the Senate. Senate leaders have said they would consider the budget override after they completed the redistricting maps, which were approved last week.

Separately, a special three-judge panel of North Carolina superior court judges has held that the legislative district maps drawn by the State's General Assembly in 2017 are unconstitutional because of the level of political partisanship used to draw them. In its order, the Court directs the Assembly to redraw the districts in time for the 2020 election. Republican legislators did not challenge the order and developed new legislative district maps.

## BMF Meeting Focuses on Workforce Growth





The next steps in following up on information from the *Window on the Workplace* study were the focus of the September NCBIO Biotech Manufacturers Forum (BMF) meeting. The study indicates that North Carolina can expect 5,000 new biomanufacturing jobs in the next five years.

NCBIO President Sam Taylor said, “NCBIO will focus on identifying education and training activities that will be needed to ensure that employees and students have the skills needed and that education institutions have the resources necessary to provide the training and courses. We will be working with the companies to get subject matter experts to meet with the academic institutions to ensure we have the resources needed to meet the needs of industry.”

Bill Bullock, Senior VP, Economic Development and Statewide Operations for the NC Biotechnology Center, focused on efforts to raise public awareness about the industry to get more people interested in careers in biomanufacturing. He noted that efforts will include workforce targets such as K-12, community colleges, universities, transferable and general workforce, military veterans, transitioning service members, and military spouses.

## NC State Receives \$27 Million Grant to Focus on Future of Biomanufacturing

---

A new five-year project led by North Carolina State University will sponsor an international collaborative research and training program in biomanufacturing science and technology. The project – “Accelerated Innovation in Manufacturing Biologics (AIM-Bio)” – is funded by the [Novo Nordisk Foundation](#), whose main objective is to “provide a stable basis for the commercial and research activities of Novo Nordisk and support scientific, humanitarian and social purposes.”

NC State will administer the \$27 million AIM-Bio program in collaboration with the Technical University of Denmark (DTU) in Copenhagen. NC State will receive \$18 million to carry out its activities, and the remainder will go to DTU. [More](#)

## At the National Level

---

### NCBIO and Other Organizations Oppose Foreign Price Controls

Legislation introduced by US House Speaker Nancy Pelosi, [The Lower Drug Costs Now](#), is drawing stiff opposition from the industry and from the Republicans on the House Energy and Commerce Committee, where the proposal will be considered. The plan would establish an international pricing index, penalize pharmaceutical companies for raising the price of drugs faster than inflation and a number of other provisions.

In response, all 24 Republicans on the House Energy and Commerce Committee criticized her partisan process to what has typically been, and should continue to be, a collaborative and bipartisan effort to bring down drug prices for the American people:

"We can solve this problem; we have solutions at the ready. We have advanced numerous policies aimed at lowering the costs of prescription drugs. In fact, in May, the House Energy and Commerce Committee passed bipartisan legislation to bring down prescription drug prices only to have Speaker Nancy Pelosi put politics over progress. Now Speaker Pelosi is back at it—pushing a socialist proposal to appease her most extreme members. It does not have to be this way; there are bipartisan solutions to bring down prices for patients and create real transparency and accountability for this system," said all 24 Republicans on the Energy and Commerce Committee.

NCBIO, BIO, PhRMA and other organizations recognize it is important to make a patient's cost of drugs affordable, and it is equally important to assure patient access without damaging innovation. That's why we need you to take action.

Congress is expected to continue debating drug pricing legislation in the coming weeks. [Now is the time to make your voice heard!](#)

[Email](#) your elected officials and tell them to oppose importing foreign price controls into the Medicare program. Let them know that price controls are bad for seniors and bad for innovation. Urge your elected leaders to support responsible solutions that lower what patients pay out of pocket for prescription medicines and support robust biomedical innovation.

### **Push to Repeal Medical Device Tax Continues**

AdvaMed, NCBIO, MDMA and other organizations continue efforts to repeal the Medical Device Tax. Unless Congress acts quickly, the U.S. medical device industry will face a \$20 billion tax increase when the excise tax goes back into effect Jan. 1, 2020. The tax, which was in effect from 2013-2015, proved to be a significant burden on innovative medtech companies, as it is a tax on sales – not profit – which is particularly devastating for smaller start-ups, most of which are not yet profitable.

The Senate and House have both previously passed repeal legislation with strong bipartisan majorities. Members of Congress from both parties joined together in late 2015 to suspend the tax from 2016 through 2017 and again in 2018 to delay it through 2019. The suspension of the tax has resulted in improvements to the ecosystem in the short-term and has enabled companies to reinvest in research and development, make new hires and provide new benefits to their employees like companywide raises and increased 401(k) matches. Still, companies are holding off on long-term investments to prepare for the possible reinstatement of the tax at the end of this year. Fortunately, there continues to be overwhelming bipartisan support for full repeal of the medical device tax in Congress.

NCBIO members are encouraged to contact members of the Congressional delegation and urge repeal of the tax.
