He obtained the highest level of certification as a PSIA Ski Instructor, earned a position on the Western Demonstration Team, and became a PSIA Examiner, clinician and ski school supervisor at Heavenly Valley California. In addition, Mark competed in many freestyle contests specializing in moguls and became Montana State Freestyle Champion, competing in multiple national and regional freestyle contests, winning a placing in many, and was a NASTAR pacesetter.
