



**Leadership Task Force  
Officer & Director Recommendations  
July 24, 2017**

**Leadership positions will be filled as follows:**

- Any Builder or Associate Member meeting eligibility criteria may run for a Leadership position (Director or Officer)
- The Officer ladder must have a minimum of one Builder and one Associate Member

Candidates for Leadership positions must meet minimum qualifications (listed below) and be certified by the Nominating Committee in accordance with Association Bylaws (Article V, VI and VIII).

**DIRECTOR**

The following are the minimum criteria to be considered eligible to run for a Director position:

- Must be a Member in good standing
- Must have been an active participant in the Association for at least one year
- Must have served on a Committee
- Must have recruited a minimum of two Members

Candidates **must have 1 additional item listed below to be considered:**

- Corporate Sponsor
- Principle, President, Vice President, Director or equivalent responsibility in individual's company
- Profit and Loss authority in individual's company or equivalent
- Prior leadership experience in other organizations
- Served as a Chair of a Committee or Taskforce
- Served on the Finance Committee
- Additional Members recruited (2 or more)
- Past Director

**OFFICERS**

**SECRETARY / TREASURER**

The following are the minimum criteria to be considered eligible to run for the **Secretary / Treasurer position**:

- Must be a Member in good standing
- Must be a current or past Board of Director Member
- Served as a Chair of a Committee or Taskforce
- Must have recruited a minimum of four Members in 24 months
- Must be or has been a Principle, President, Vice President, Director or have equivalent responsibility in individual's company Profit and Loss authority in individual's company or equivalent
- *\*Prior GOBA Finance Committee service will be weighed in overall criteria for eligibility.*

**VICE PRESIDENT**

The following are the minimum criteria to be considered eligible to run for the **Vice President position**:

- Must be a Member in good standing
- Must be a current or past Board of Director Member
- Served as a Chair of a Committee or Taskforce
- Has served as the Chair of the Finance Committee
- Must have recruited a minimum of six Members in 36 months
- Must be or has been a Principle, President, Vice President, Director or have equivalent responsibility in individual's company profit and Loss authority in individual's company or equivalent

**PRESIDENT**

The following are the minimum criteria to be considered eligible to run for the **President position**:

- Must be a Member in good standing
- Must be a current or past Board of Director Member
- Served as a Chair of a Committee or Taskforce
- Has served as the Chair of the Finance Committee
- Must have recruited a minimum of eight Members in 48 months
- Must be or has been a Principle, President, Vice President, Director or have equivalent responsibility in individual's company profit and Loss authority in individual's company or equivalent

**IMMEDIATE PAST PRESIDENT**

The President will automatically move to the position of Immediate Past President upon completion of their term as President.
