



## ***Hall of Fame Inductees***

**Nominee for induction into the Greater Orlando Builders Association (GOBA) Hall of Fame are selected from (4) categories:**

1. Builder/Remodeler/Developer
2. Trades Professionals and Suppliers
3. Government
4. Industry-allied Professionals (all others involved in the building industry; including but not limited to lenders, architects, engineers, land planners, manufacturers, educators, media personnel, trade association staff)

### **Sources of Nominees**

Potential nominees are collected from various sources:

1. Greater Orlando Builders Association
2. Hall of Fame Governors and Members
3. Members

### **Guidelines for Submission of Nominees**

1. All submissions must be made on OFFICIAL Hall of Fame application form.
2. Nominees are not limited to Past Leaders or Senior Officers. Nominees may be Builder/Developer/Remodeler, Trade Professionals and Suppliers, Government officials or employees, Industry-allied Professionals and other Professionals whom may have had impact on the industry. Association membership is not required.
3. In the case of a nomination submitted for a former GOBA Senior Officer, the nominee must have been an individual who served the association a minimum of fifteen (15) years and has been out of senior office (including service as Immediate Past President or Immediate Past Associate Vice President) for five years prior to the nomination date. This is for the nominees first term as a Senior Officer for members that may be serving multiple Senior Officer terms.
4. Financial success or size of a nominee's business operation shall not be considered a significant and lasting contribution. The contribution must have resulted in a substantial improvement and innovation in Florida's housing and home building industry.
5. Submission of a name does not guarantee that the individual will inducted into the Hall of Fame.

## **Board of Governors**

1. The Board of Governors will consist of nine (9) Hall of Fame Members. Five Governors shall be builder members and four associate members.  
\*The Formation Committee shall serve as the Board of Governors until the Hall of Fame Committee is established.
2. The Chair of the Board of Governors will be elected by the Board of Governors following the Installation of Officers, but no later than January 31 of each year and serve a one-year term, which begins immediately following the Installation of Officers in which he/she was elected.
3. Each Year, following the Installation Ceremony, but no later than January 31<sup>st</sup> of the following year, the Board of Governors may nominate new Board members to serve on the Board. The existing Board of Governors will select the new members from the nominated members striving where possible for a balanced geographic representation and insuring the proper mix of builder/associate.

## **Election of Hall of Fame Members**

1. Voting is by secret ballot.
2. Each Governor has the responsibility of carefully evaluating each nominee and completing the ballot.
3. A nominee must receive a minimum of at least six (6) votes (two-thirds vote of the Board of Governors) to be inducted.
4. All eligible previously nominated but unelected nominees will be reconsidered annually.
5. A nominee nominated three times (not including applications returned as incomplete) without induction may submit a new, complete application after waiting a period of at least three (3) years from the date of their first consideration.
6. When an individual is up for nomination for the third time, a notation shall be placed on the ballot indicating such for the information of the Board of Governors.
7. Individuals endorsing previously nominated but unelected nominees will have the opportunity annually to update the nominee's application. (Note: this process does not extend the maximum three-year period that a nominee can be considered without election.

## **Announcement of Election Results**

Formal announcement of ballot results is made by the Chair of the GOBA Hall of Fame Board of Governors during the Greater Orlando Builders Association Installation Ceremony.

New inductees who are present at the ceremony are recognized at the time of the announcement by the Chair.

## **Induction Ceremonies**

The induction ceremonies take place during the Annual Installation Ceremony in the Fall.

Activities are planned and coordinated with the GOBA President and Executive Officer to eliminate scheduling conflicts and to insure their support and participation.

The new inductees, their families and special guests are contacted and invited to attend the various activities planned by the Board of Governors. The Governors serve as the host/hostesses to the new inductees during the ceremony.
