Any entity having a commercial interest in the hearth, patio and/or barbecue industry, including—but not limited to—gas utilities, publications, testing laboratories, insurance agencies, financial institutions, business systems providers, advertising agencies, public relations firms, etc.

Non-Profit \$175/Yr \$46.25/Qtr* \$17.08/Mo*

Any entity having a non-profit, non-commercial interest in the hearth, patio and/or barbecue industry.

Non-Resident \$150/Yr

Any entity having a commercial interest in the hearth, patio and/or barbecue industry in the Northeast region *who already has a current membership in their respective HPBA affiliate*.
