RE: June 1, 2020 Wage Increase and Fringe Benefit Allocation - Laborers' Local #238 and #348

Heavy/Highway and Building Construction Labor Agreement

#### Ladies and Gentlemen:

Allocations have been made for the previously negotiated total package increase of \$1.50 per hour in Eastern Washington effective June 1, 2020. The total package increase has been allocated with \$.20 per hour to Health & Welfare, \$0.40 per hour to Pension, \$0.05 per hour to Training and the remaining \$0.85 to wages. There has also been an increase of \$0.06 per hour to the Union Dues deduction. The revised wage and fringe benefit rates through May 31, 2021 are as follows:

**REMINDER:** Under the provisions of Article 22, Public Works Projects, you must make any adjustment on the Health & Welfare contribution even though the wage rates and remaining fringe benefit contributions are frozen for the initial 24 months or duration of the project, whichever is the lesser.
