2019 SCHOLARSHIP APPLICATION

To receive the FPMA Scholarship, an applicant must be a Florida resident meeting one of following criteria: (A) owns or is employed by an FPMA Member company; (B) is a financial dependent of an owner of an FPMA member company; (3) is a financial dependent of an employee of an FPMA member company.

Eligible applicant must take a minimum course load of 12 hours. Receipt of the scholarship award cannot be postponed. The scholarship award is to be used for tuition and books only.

The scholarship is for undergraduate students and can be used for in-state, out-of-state, private, and public schools. Scholarships are awarded in the amount of \$1,500 per semester (Fall & Spring) over a period of two consecutive years, for a total award of \$6,000. Applicants in their senior year of college will receive the award for their final year in the amount of \$1,500 per semester (Fall & Spring), for a total award of \$3,000. All scholarship applicants must have a cumulative 3.5 minimum g.p.a (on a 4.0 scale) to apply for the FPMA Scholarship.

High school applicants must include an official, sealed high school transcript. Applicants who have attended more than one year of college must send official sealed college transcript. If transcripts are not included, your application will not be considered eligible for scholarship award.
