## Special Resolution 78

The following types of work may be bid using Res Light Journeymen or Building Trades Journeymen wage packages and need no prior approval. However, contractors must complete the Special Resolution 78 Form (attached below) and remit to SMACNA Detroit.

- 1 All three-story hotels
- 2 All shopping centers
- 3 All restaurants
- 4 Strip stores & retail establishments except union work
- 5 Churches
- 6 Big-box stores and similar
- 7 Professional medical, dental and office buildings including new tenant remodels for these buildings
- 8 Municipal, township, public & private schools
- 9 Condominium buildings
- 10 Auto dealerships
- 11 Grocery stores
- 12 Assisted living facilities
- 13 Drugs store / pharmacies
- 14 Bank branches
- 15 Movie theaters

This agreement applies exclusively to HVAC field work. When working at either rate, selection will be from the top to the bottom of the out-of-work list. Building Trades Journeymen who accept work on the above projects will retain their positions on the out-of-work list. Section 26(3).

The Local 80 Business Manager shall have discretion if in his opinion a particular job in one of the above categories should be bid at the un-reduced Building Trades total package. However, in order to be effective, the Business Manager must notify in writing the SMACNA Detroit association office 24 hours in advance of the bid date. SMACNA Detroit will in turn notify its members of this decision. This does not apply to project labor agreements, prevailing wage jobs or any union only competition. Such discretion by the Business Manager shall not be unreasonable or abused.
